

Resolutions of the Global Meet of AMPS on

8th & 9th March, 2025 at Bhubaneswar, Odisha

Dear Brothers and Sisters,

Namaskar,

The Global meet of AMPS was held on 8th and 9th march, 2025 at Bhubaneswar, as per schedule. It was attended by *margis and* WT workers from different states/countries of Delhi Sector and different parts of the globe both in-person and on-line. The two-day meeting unanimously resolved as follows.

1. *Margis* and WTs shall work ceaselessly with the sole objective of having one DMS, one Seminar and one Administration.
2. *Margis* and WTs keen to bring about unity shall not associate or co-operate with any factional administration or with *margis* who seek to keep organization divided..
3. Grass-root structures are to be strengthened and more enabling circumstances are to be in place through ideological education of the *margis* and Wts.
4. The committee shall work for the decentralization of the Judiciary, Administrative and Legislative powers at the center.
5. The issues relating to creation of *Purodhas* which led to factionalism are to be discussed at the appropriate time;
6. *Margis* shall stop all financial assistance to factional administrations;
7. *Margis* and WTs from the existing factions shall be encouraged to participate in the collective functions like DC, *Sadhana Shiviir, Akhanda Kiirtan and Service activities.*

8. A Public Interest Litigation (PIL) be filed by *margis* in the appropriate court requesting the Judiciary to intervene and issue appropriate decree in favour of a single spiritual congregation of *margis* and WTs i.e, *Dharma Maha Sammelan* (DMS) on 30th, 31st and 1st January as it was the case during physical presence of **Marga Guru**.
9. The GCU shall be constituted within a period of two months from 9th March 2025, as per the following principles:-
 - a. 50% *Grhiis* (householders) and 50% WTs shall be part of the Committee;
 - b. 60% *margis* / WTs from Delhi sector and 40% of *margis* and WTs from overseas sectors shall be part of the committee;
 - c. There will be minimum of 30% representation by sisters and *didis* in the committee, both from India and overseas;
 - d. Minimum of 2 or maximum of 4 from each state of Delhi sector shall be members of the committee;
 - e. The members must have been: a) Organizationally active for Unity b) Strict in their spiritual practices i.e, steadfastness in *sadhana* twice a day; sentient diet; regular attendance in the weekly DC; fasting; steady in the practice of *Yama* and *Niyama*. The Convener shall have tenure for a period of one year.
10. A team of *margis* and WTs, duly approved by Global Co-ordination Committee shall take the initiative for friendly dialogue with factional administrations to facilitate unity.
11. After the formation of the Global Co-ordination Committee (GCU), the present committee shall cease to be functional. The GCU shall strive with

the sole goal of bringing about robust, sustainable, ideological unity of AMPS and shall stand dissolved when it is achieved.
